Providing these education events and activities is our way of being good stewards to our Central Florida ISACA Membership; we hope you enjoyed them, and we look forward to seeing you at future education and social events!

Our Education Committee is currently reviewing education and speaker programs for 2019; anticipate a communication of upcoming events in January 2019. From your training evaluations you have also expressed a need for more CISA, CISM, CRISC and CSX exam prep training. To ensure training organizations and trainers are delivering the most relevant educational experience ISACA has created the Accredited Partner Program this past year. This past year one of our own Central Florida Chapter members (*Ashish Vashista*) was officially accredited by ISACA Headquarter CISA and CISM as an Accredited Partner. Accredited Partners offer greater value to their certification candidates because:

- Trainers are pre-qualified against a set of standards and requirements by ISACA
- Trainers have gone through the rigors of accreditation both on their subject matter expertise, as well as, their training ability through an independent company hired by ISACA
- Refreshed training materials are provided by ISACA to Accredited Partners as updates to the certification program and better aligned to exam-taking and passage rates.

Ashish Vashista is planning to offer additional exam prep classes in the May and July-August timeframe in 2019. Keep an eye out for advance notification and an invitation to register to attend via Email, on our **CFL-ISACA Chapter website** and on **LinkedIn**.

College students preparing to graduate expressed a need to be introduced into this profession with our participation in Higher Education job fairs and internships with local area businesses. #### Free Tools for Your Anti-Fraud Toolbox

The Association of Certified Fraud Examiners (ACFE) has launched a FREE set of Fraud Risk Management (FRM) tools to complement the *Fraud Risk Management Guide*. Developed by The Committee of Sponsoring Organizations of the Treadway Commission (COSO) and the ACFE, the *Guide* details how organizations can most effectively create and enhance their FRM programs. You do not have to be an ACFE member to take advantage of these FREE FRM tools.

#### The FRM toolbox includes:

#### **Interactive Scorecards**

Use interactive scorecards to assess the components of your organization's existing fraud risk management program. Based on the five fraud risk management principles found in the *Fraud Risk Management Guide*, the scorecards support an organization's periodic self-assessment.

#### **Library of Anti-Fraud Data Analytics Tests**

Explore an interactive tool that details, by fraud risk type, how to integrate data analytics tests into your fraud risk assessment or investigative work plans. The library of test examples illustrates a variety of tests to consider and organizes them by categories of occupational fraud risks.

#### **Risk Assessment and Follow-Up Action Templates**

Using the fraud risk assessment matrix in the *Fraud Risk Management Guide* as your foundation, this spreadsheet provides a risk assessment matrix for you to document any organization's fraud risks and controls. The template automatically creates a heat map showing the significance and likelihood of each identified fraud exposure, a fraud risk ranking page displaying each fraud risk exposure from most to least severe, and a control-activities matrix showing the identification and evaluation of existing control activities related to each fraud risk exposure. It also provides space to identify additional control activities and to record the organization's response plan for each exposure. In addition, the template contains pages to record allegations of suspected fraud, document investigations and outcomes, and document fraud risk management monitoring plans.

#### Points of Focus Documentation Templates

Use the templates to help create consistent and uniform documentation related to fraud risk governance, fraud risk assessment, fraud control activities, fraud investigation and follow up, and fraud risk management monitoring.

The *Fraud Risk Management Guide* is a best-practice guide to help organizations implement COSO Principle 8, which addresses the importance of assessing fraud risks.
